

End-of-Sale and End-of-Life Announcement for the MiCor A100 Wearable ECG Recorder

MiTAC Digital Technology Corp. announces the end-of-sale and end-of-life dates for the MiCor A100 Wearable ECG Recorder. Depending on available stock, the last day to order the affected product(s) is <u>July 20, 2018</u>. Please be advised that no sales to end-users are allowed under CE regulations after <u>July 31, 2018</u>.

This decision has impacted the continuation of the following certification standards, which will come to expire on July 31, 2018 and will not be extended:

- Medical Device Directive 93/42/EEC CE marking (MDD)
- ISO 13485

What does this mean for you and your customers?

- Devices already deployed with end-customers will not be affected in any way and the product can continue to be used without any legal (or other) implications.
- Selling or placing the product on the market after July 31, 2018 is legally not allowed. This applies to both MiTAC as the manufacturer of the product, as well as all MiTAC distributors and/or resellers.
- For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
- Product software (i.e. MiCor application on Android Play Store and Apple App Store)
 will continue to be available and supported at least 2 years after this EOL announcement, until June 1, 2020.
